Meet our new Social Worker, Courtney

Hi! I'm Courtney, I'm employed as a social worker at the Service for two days a week and I'm really excited to have started. TRANS ATHLETES COMPETE IN TOKYO OLYMPIC GAMES

he 2020 Tokyo Olympic Games saw 183 publicly out LGBTIQ+ athletes compete, which was more than triple that of the 2016 Rio Games. This represents the progressive cultural change taking for LGBTIO+ place athletes. The Tokyo Games were particularly significant because of the inclusion of transgender athletes. Canadian soccer player, Quinn (pictured middle), became the first trans and non-binary athlete to a win gold medal. New weightlifter, Zealand Laurel Hubbard (pictured right), became the first trans woman to compete individual event. in an Additionally, Alana Smith, who identifies as non-binary, also competed in the park skateboarding event for the United States.

The International Olympic Committee ("IOC") is in the process of reviewing guidelines relating to trans athletes. The current policy, developed in 2015, permits trans women to compete in women's events if they can demonstrate that their total testosterone level in serum has been below 10 nmol/L for at least 12 months prior to their first competition, with any longer period testosterone suppression to be based on a confidential case-bycase evaluation. The IOC is considering whether 12 months is a sufficient length of time to minimize any possible advantage trans woman may have. According the current to guidelines, the athlete's testosterone level must remain below 10 nmol/L, monitored by testing, throughout the period of eligibility to compete.



Quinn won gold after Canada upset tournament favourites, Sweden, in the gold medal match of the women's soccer.

The IOC rules state that if an athlete affirms their gender, this affirmation cannot be altered for minimum of four vears. athletes Currently, who transition from female to male are eligible to compete in any male event without restriction. However, the IOC remains in an ongoing consultation process regarding a policy balance which will promote fair competition without excluding trans athletes.

Quinn, who plays for OL Reign in the National Women's Soccer League, was the first openly trans non-binary athlete to win a gold medal. Canada defeated Sweden in the women's soccer final via a penalty shootout after scores were tied 1-1 after regulation and extra time. Quinn came out prior to the Games to encourage others to follow suit. In an interview, Quinn said, "It's my hope that there are other people following in my footsteps and so I hope that it opens the door for trans athletes being represented at the Olympics".



Laurel Hubbard is the first ever trans athlete to compete in a women's Olympic event.

Laurel Hubbard's competition in women's weightlifting also drew significant international media attention. The event received over triple its ordinary viewership. Unfortunately for Hubbard, she failed all three attempts at her 'snatch lift', which eliminated her from progressing to the next round of the event. Hubbard stated in interview after eliminated, "I would particularly like to thank the IOC, for I think really affirming its commitment to the principles of Olympism and establishing that sport is something for all people, that it is inclusive and is accessible."

Alana Smith was also knocked out in the early stages of the park skateboarding event.

The inclusion of trans and nonbinary athletes at the 2020 Tokyo Olympic Games represent positive and progressive change that protects the inclusivity of all athletes wishing to compete in future Games. However, we hope that ongoing consultations in relation to Olympic policy result in further inclusion for LGBTIQ+ athletes whilst also maintaining fair athletic competition.

A New Court - Reform or Reshuffle?

From 1 September 2021 a new Court, the Federal Circuit and Family Court of Australia (FCFC) became the single entry point for all family law matters. Earlier this year, Federal Parliament passed legislation to merge the Family Court of Australia with the Federal Circuit Court to form this new Court.

The FCFC has two divisions within the Court system:

- FCFC Division 1, which functions like the previous Family Court of Australia; and
- FCFC Division 2, which functions much like the previous Federal Circuit Court.

Division 1 of the FCFC deals exclusively with family law matters while Division 2 of the FCFC will hear family law matters as well as other federal law matters, such as Workplace Law, Bankruptcy, Consumer Law, and Intellectual Property.

The FCFC will have a one set of Court forms and administrative rules for the Court's function and procedures. The newly merged Court is intended to streamline the process for family law matters to proceed to resolution.

All family law matters must be lodged in the FCFC Division 2 where a Judge or Registrar will commence the case management process to prioritise matters, schedule Court events and ensure the matter is heard in the most appropriate FCFC division. For matters already before the Court, transitional arrangements are in place. This means that the Court will ensure that all existing matters are dealt with as efficiently as possible to minimise any disruption in the initial period of the new Court's operation.

The merger has been widely opposed by members of the family law profession, with a concern that it will ultimately lead to less specialisation and that more funding for specialist family law Judges, rather than yet another revamp of the structure, is really what is required in the already overburdened system.

Advocates in the domestic violence sphere have been particularly concerned that Judges without extensive training regarding the complex intersection of family law and violence may be called upon to hear and determine matters involving these issues, further exposing vulnerable parties and children to such violence.

It remains to be seen whether the reforms are simply a reshuffle of Judges in a still under-resourced system, or whether more positive outcomes will follow for litigants who now have more timely access to Court intervention and easier to follow processes.
